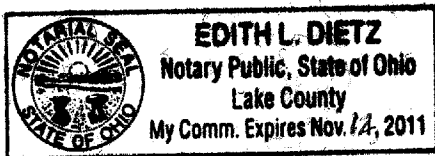

I, THEODORE KENESKY, of Lake County, Ohio, being of lawful age and sound mind do hereby make, publish and declare this to be my Last Will and Testament, revoking all previous Wills, Testaments and Codicils heretofore made by me.

ITEM I

I direct that all my just debts and funeral expenses be paid out of my estate. My fiduciary shall also pay all inheritance, estate and other death taxes out of the principal of my estate. The estate shall not be entitled to reimbursement from any of the beneficiaries therefore.

ITEM II

I am married and the name of my spouse is DOLORES T. KENESKY. All references in this Will to my spouse are to her.

ITEM III

I have four (4) children of this marriage as follows:

SHARON L. CHRISTMAN
JAMES J. KENESKY
THEODORE J. KENESKY

ITEM IV

I give, devise and bequeath my entire estate, whether real, personal or mixed, of every kind, nature and description, whatsoever and wheresoever situated, which I may now own or hereafter acquire or have the right to dispose of at the time of my decease, by power of appointment or otherwise, to my spouse, absolutely and in fee simple.

ITEM V

Should, however, my said beloved spouse predecease me or fail to survive me by thirty (30) days, then Item IV shall fail and be of no effect, and in that event, I give, devise and bequeath my entire estate, whether real, personal or mixed, of every kind, nature and description whatsoever and wheresoever situated, which I may now own or hereafter acquire or have the right to dispose of at the time of my decease, by power of appointment or otherwise, to my children, GARY F. KENESKY, SHARON L. CHRISTMAN, JAMES J. KENESKY and THEODORE J. KENESKY, absolutely and in fee simple, share and share alike, with representation.

ITEM VI

I nominate and appoint DOLORES T. KENESKY, Executrix (herein referred to as fiduciary) of this, my Last Will and Testament, to serve without bond, hereby granting to my fiduciary full power and authority to sell and convey all or any part of my estate, real, personal or mixed, upon such terms and at such prices as my fiduciary may deem proper, and without obtaining any order of court therefore. I also grant to my fiduciary full power and authority in the settlement of my estate to compromise, compound, adjust and settle any and all debts and liabilities due to or from my estate, for such sums and upon such terms and conditions and in such manner as my fiduciary shall deem best. I further grant to my fiduciary full power and authority to conduct and carry on for such length of time as my fiduciary may deem advantageous to my estate, any and all business or businesses now conducted by me, and to do all things necessary and proper in the usual course of said business or businesses until such time as the same can be sold, as a going business or otherwise, for a price which, in the sole opinion of my fiduciary is a reasonable value thereof, and shall in so doing be exonerated from any loss which might result thereby.

If DOLORES T. KENESKY should predecease me or for any reason fail to qualify or decline to act as my fiduciary, I nominate and appoint SHARON L. CHRISTMAN as my fiduciary to serve without bond.
