WHEREAS, we, Christian Riedel of Bliedersdorf, Germany, and Michael Weidel of Giesen, Germany, hereinafter ("Assignors"), have invented certain new and useful improvements in DEVICE FOR ATTACHING AN AIRCRAFT CABIN MODULE for which application for a U.S. Patent was made on July 14, 2010 as U.S. Patent Application Serial No. 12/836,282 based on PCT International Application No. PCT/EP2009/050954 filed January 28, 2009, which claims priority to U.S. Provisional Patent Application Serial No. 61/062,580 filed January 28, 2008 and German Patent Application No. 10 2008 006 433.5 filed January 28, 2008.




