

Assignment Agreement and Resolution


1. This agreement is between LRH ENTERPRISES, INC., a California Corporation, (SELLER) and PRAETORIAN INDUSTRIES, INC., a Washington Corporation doing business at 18017 121st Ave East, Puyallup, WA, 98374, (BUYER).
2. SELLER agrees to sell, transfer, and assign all right, title, and interest in United States patent Serial No. US 6,173,637 of inventors Normand and Ralph Hubert covering "Molding Cutter Head" to BUYER for the total sum of FOUR THOUSAND DOLLARS (\$4,000) (of which \$3,600 made payable to the law offices of ELLIOTT N. KRAMSKY, and \$400 made payable to LRH ENTERPRISES, INC.). SELLER warrants that the entire right, title and interest in said patent was previously assigned to it by the inventors.
3. This agreement is effective as of October 15th, 2010.
4. SELLER and its shareholders agree to indemnify and hold BUYER harmless from any debts and/or obligations of SELLER and further agree to not compete with BUYER in the woodworking industry for a period of 10 years subsequent to this Agreement.
5. SELLER and its shareholders agree not to disclose any details of this transaction to anyone without the prior express written consent of BUYER.
