This Agreement is made this 30 day of September 2009 between

(1) **Aibel AS**, registered in Norway with company number 984 735 227 and having its registered office at Vestre Svanholmen 14, 4313 SANDNES, Norway;

(2) **Aibel Gas Technology AS**, registered in Norway with company number 979 945 124 and having its registered office at Sandslihaugen 1, 5861 BERGEN, Norway;
(together the Assignors)

and

(3) **Hamworthy plc** (the Assignee), registered in England and Wales, and having its registered office at Fleets Corner, Poole, BH17 0JT, UK.

BACKGROUND

The Assignors owns and uses in its business certain inventions under certain patents, patent applications and trade marks listed in the Schedule to this Agreement.

By an asset purchase agreement dated 7 July 2009 between Aibel AS and the Assignee (the Asset Sale and Purchase Agreement), and further by a closing protocol dated 29 September 2009 between the Assignors and the Assignee (the Closing Protocol) the Assignors has agreed to assign the right, title and interest the Assignors may have in the patents, patent applications and trade marks listed in the Schedule to this Agreement (the IPR) to the Assignee in the terms set out in this Agreement.

AGREED TERMS

1. Assignment

1.1 In consideration for entering into the Asset Sale and Purchase Agreement and the Closing Protocol and the consideration paid thereunder, the Assignors hereby transfers and assigns to the Assignee whatever right, title and interest the Assignors may have throughout the world in and to the IPR.

1.2 The Assignors agrees to execute all documents and assignments and to perform such other acts as Assignee may reasonable request to secure to it the rights hereby conveyed.

1.3 Assignors shall duly execute and deliver or cause to be executed and delivered all instruments of conveyance, transfer and assignment and they shall perform such further acts as may be necessary to convey, transfer, assign and deliver to, and consolidate, vest and record in Assignee, full ownership of the IPR.

2. Provisions relating to this Agreement

2.1 All cost related to preparation of sufficient notifications to be sent to the relevant trademark and patent authorities (filings) are to be borne by Aibel AS, while the cost related to sending the notification together with applicable fees from the relevant authorities connected to the change of ownership shall be borne by the Assignee.

2.2 Aibel AS will use its best endeavours to ensure that the correct notifications (filings) to the relevant patent and trademark authorities, less the signatures from the Assignee if needed, are prepared as soon as possible. Aibel AS will appoint Bryn Aarflot AS to complete this work. Aibel AS shall report weekly to the Assignee regarding the progress of the preparation of the filings.

2.3 This Agreement has been executed and delivered pursuant to the Asset Sale and Purchase Agreement and the Closing Protocol but shall not be deemed to modify or supersede either the Asset Sale and Purchase Agreement or the Closing Protocol.

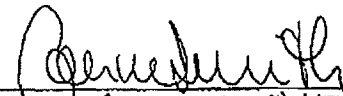
2.4 All questions concerning the construction, validity and interpretation of this Agreement and the performance of the obligations imposed by this Agreement shall be governed by the laws of Norway.

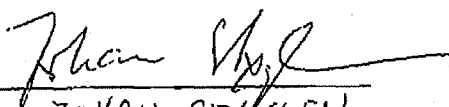

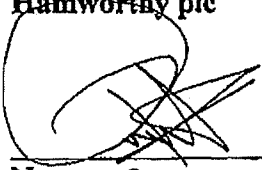
