ASSIGNMENT

WHEREAS, we, **Rodolfo R. Llinas**, being a citizen of the United States of America, residing at 16 Sutton Place, New York, New York 10022, USA; **Mutsuyuki Sugimoro**, being a citizen of Japan, residing at 3 Washington Square Village, Apartment 5-D, New York, New York 10012, USA; and **Francisco Urbano**, being a citizen of Spain, residing at 2233 Ocean Avenue, Apartment 3-D, Brooklyn, New York 11220, USA are the inventors of certain new and useful inventions and discoveries, entitled "**METHODS AND COMPOSITIONS FOR TREATING THALAMOCORTICAL DYSRHYTHMIA**" also identified as Attorney Docket Number 291472.132US2 / NYU-011US, the specification of which was filed with the United States Patent and Trademark Office as a non-provisional patent application on **March 10, 2008** and has been assigned Application No. **12/045,265**.
