ASSIGNMENT

WHEREAS, Joe B. Sudkamp, Steven R. Madden and Mark N. Middleton, residing at 9773 E. 1735th Avenue, Shumway, IL 62461; 4 W. Madison Avenue, Altamont, IL 62411; and 7967 Wilson Road, Kinmundy, IL 62854, respectively (hereinafter referred to as Assignors), have invented certain new and useful improvements in BLEACHER SEATING SYSTEM, for which a United States provisional application, Serial No. 61/256,672, was filed on October 30, 2009, and for which an application for United States Letters Patent was executed on even date herewith.

FURTHER, Assignors agree to communicate to said Assignee or its representatives any facts known to Assignors respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all utility, divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
