WHEREAS, *We, Charles Kannankeril, residing at 38 Fox Run, North Caldwell, New Jersey, 07006, and Ian M. Donegan, residing at 6 Tall Timber Drive, Morristown, New Jersey, 07960,* have made an invention generally relating to mailers for shipping objects, and more particularly to mailers comprising an outer pouch and an inner inflatable liner and an inflation pathway through which a portion of gas can be introduced into said inflatable liner. Such invention is described in an application for Letters Patent of the United States entitled, Inflatable Mailer, Apparatus, and Method for Making the Same, bearing attorney docket number D-44314-02, executed concurrently herewith, filed October 28, 2010, and assigned U. S. patent application serial number 12/913850. This application is a continuation-in-part of U. S. Patent Application Serial Nos. 12/387,577 and 12/387,572, both filed May 5, 2009.



And we do hereby agree for ourselves and for our heirs, executors, and administrators to execute any lawful document and to testify as to any material


