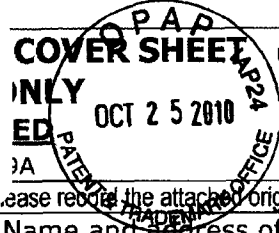

I, the undersigned, Daniella Atzmony, bearer of Israel ID Card No. 022031678, after being warned that I must tell the truth and that I would be liable to the penalties prescribed by law should I fail to do so, hereby declare as follows:


1. I am the Chief Intellectual Property Officer of RF Dynamics Limited.
2. On 21 February 2008, inventors Eran Ben Shmuel, Ginadi Shaham, Alexander Bilchinsky and myself, (hereinafter the "**Inventors**"), all employees of RF Dynamics Limited at the time filed together with RF Dynamics Limited a PCT application entitled Drying Apparatus And Methods And Accessories For Use Therewith as Patent Cooperation Treaty Application Serial No. PCT/IL2008/000,231 (the "**PCT Application**").
3. All four Inventors were obligated by law and contractual obligation to assign their interest in the subject invention to RF Dynamics Limited, or as RF Dynamics Limited should instruct.
4. In my capacity as the IP manager of RF Dynamics Limited I was instructed by RF Dynamics Limited's senior management that the PCT Application directed to the subject invention was to be assigned to Bora Appliances Limited, a related company of RF Dynamics Limited that was being established at that time to exploit the technology disclosed in the PCT Application.
5. Accordingly, all Inventors duly executed the documents for the assignment of the Patent Application to Bora Appliances Limited. The assignment was duly recorded, and the named applicant was recorded as Bora Appliances Limited.
6. I have now been made aware that Bora Appliances Limited was never established. The instruction to assign the Patent Application to Bora Appliances Limited was an unintentional and inadvertent mistake made in good faith.
7. I therefore request that the assignment of the Patent Application by the Inventors to Bora Appliances Limited be deemed null and void, and that RF Dynamics

Limited be recorded as the assignee and Applicant of the above identified Patent
Application and all national stage applications emanating therefrom.


