**ASSIGNMENT**

WHEREAS, WE, FRANCISCUS VAN DEN BOSCH, a citizen of the Netherlands, residing at Achterdorp 1, 4041 GJ Kesteren, The Netherlands, and MEINARDUS PETRUS BOON, a citizen of the Netherlands, residing at Drieboomlaan 290, 1624 BV Hoorn, The Netherlands, are the inventors of an invention in "INBRED BROCCOLI LINES BRM50-3905 AND BRM50-3906" for which we have executed an application for Letters Patent of the United States, with Application Serial Number 09/845,672, filed April 30, 2001; and

WHEREAS, Seminis Vegetable Seeds, Inc., incorporated in the state of California, with a place of business at 37437 State Hwy. 16, Woodland, California 95695, is desirous of obtaining the entire right, title and interest in, to and under the said invention and the said application;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, we the said FRANCISCUS VAN DEN BOSCH and MEINARDUS PETRUS BOON have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said Seminis Vegetable Seeds, Inc., its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said invention, and the said application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said invention in any country or countries foreign to the United States, and all Letters Patent which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof and all rights of priority in any such country or countries based upon the filing of the said application for Letters Patent of the United States which are created by any law, treaty or international convention; and we hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said invention to the said Seminis Vegetable Seeds, Inc., its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to said Seminis Vegetable Seeds, Inc., its successors, legal representatives and assigns, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said Seminis Vegetable Seeds, Inc., its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said invention in all countries.
