ASSIGNMENT

WHEREAS, We, Sascha Bussat of Bergen, Norway, Peter Hanssen, of Bergen, Norway, and Simone Patricia Kugler, of Bergen, Norway, have invented certain new and useful improvements in METHOD OF AND APPARATUS FOR EXPLORING A REGION BELOW A SURFACE OF THE EARTH, for which an application for Letters Patent of the United States has been made, and which may be identified in the United States Patent Office by Application No. 12/809,467, filed June 18, 2010.
