Assignment of Invention

WHEREAS, we, Brian L. UHLHORN, of 605 Snelling Avenue South, Unit 210, St. Paul, Minnesota 55116 U.S.A.; Stephen M. SOHN, of 252 County Road F West, Shoreview, Minnesota 55126 U.S.A.; and Howard J. SCHANTZ, of 11108 Albavar Path, Inver Grove Heights, Minnesota 55077 U.S.A., have invented certain new and useful improvements in METHOD FOR DATA FRAME REDUCTION IN A PHOTONIC-BASED DISTRIBUTED NETWORK SWITCH.

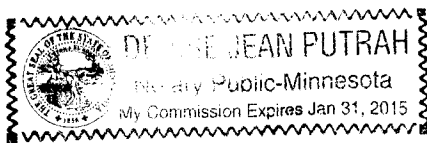
