may reasonably request to effectuate fully this assignment.

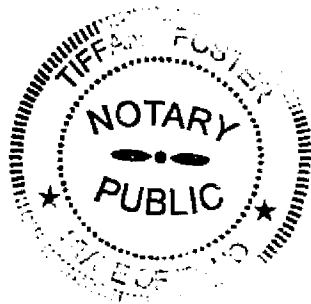
