ASSIGNMENT

WHEREAS, IRIDIGM DISPLAY CORPORATION (hereinafter "ASSIGNOR"), a Delaware corporation, having a principal place of business at 2415 Third Street, San Francisco, California 94107, has certain rights in improvements related to PACKAGING FOR AN INTERFEROMETRIC MODULATOR, for which U.S. Patent Application No. 10/844,819 was filed on May 12, 2004;

AND WHEREAS, IDC, LLC, (hereinafter "ASSIGNEE"), a Delaware limited liability company, with its principal place of business at 2415 Third Street, San Francisco, California 94107, desires to acquire ASSIGNOR'S entire right, title and interest in and to said improvements and the said Application;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR does hereby acknowledge that it has sold, assigned, transferred and set over on October 1, 2004, and by these presents does hereby sell, assign, transfer and set over with an effective assignment date of October 1, 2004, unto the said ASSIGNEE, its successors, legal representatives and assigns, ASSIGNOR'S entire right, title, and interest throughout the world in, to and under the said improvements, including said Application and any provisionals, divisions, renewals and continuations thereof, and all Patents of the United States which may have been or may be granted thereon and all reissues and extensions thereof, and all rights of priority under International Conventions and applications for Patents which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Patents which may be granted for said improvements and in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and ASSIGNOR hereby authorizes and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Patents for said improvements and to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND ASSIGNOR HEREBY sells, assigns, transfers, and conveys to ASSIGNEE, its successors, legal representatives, and assigns all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the said Patent, before or after issuance;

AND ASSIGNOR HEREBY covenants and agrees that it will communicate to ASSIGNEE, its successors, legal representatives, and assigns any facts known to it respecting said improvements, and will designate an individual on its behalf to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives, and assigns to obtain and enforce proper patent protection for said improvements in all countries.

NOTWITHSTANDING the foregoing provisions, this instrument shall not affect any of ASSIGNOR'S rights in said improvements, as licensed by ASSIGNEE to ASSIGNOR in a Patent License Agreement entered between ASSIGNEE and ASSIGNOR on October 1, 2004.
