TERMINATION AND RELEASE OF PATENT COLLATERAL SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF PATENT COLLATERAL SECURITY AGREEMENT (this "Agreement") dated as of November 5, 2010, is by and between the individuals and entities listed on Exhibit A (collectively, "Lenders") and Evident Technologies, Inc., a Delaware corporation (the "Company").

WHEREAS, the Company and the Lenders were parties to a certain Secured Credit Facility Agreement dated January 9, 2008 (the "Credit Agreement"), pursuant to which the Lenders agreed to make certain loans and provide certain financial accommodations to the Company, as particularly set forth therein; and

WHEREAS, in order to secure the Company's obligations to the Lenders under the Credit Agreement and pursuant to the terms of that certain Security Agreement between the Company and the Lenders, dated January 9, 2008 (the "Security Agreement"), the Company executed and delivered in favor of the Lenders that certain Patent Collateral Security Agreement dated January 9, 2008 (the "Patent Security Agreement"), pursuant to which the Company collaterally assigned, granted and conveyed to the Lenders a lien and security interest in and to the patents and patent applications as more fully described on Exhibit B attached hereto and made a part hereof and the inventions described and claimed therein (the "Patents"), all registrations and applications for registration of the Patents (as well as any reissues, extensions, divisions or continuations of the Patents), together with all of the Company's right to sue and recover for infringement of the Patents; and

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on January 9, 2008 at Reel 020339, Frame 0174, and a Corrective Assignment was recorded on January 15, 2008 at Reel 020365, Frame 0563; and

WHEREAS, in connection with the Order of Confirmation of the Debtor's Plan of the United States Bankruptcy Court, Northern District of New York dated April 20, 2010 and entered April 21, 2010, under which the Patents were vested in the Company free and clear of the claims of the Lenders, the Company has requested that the Lenders, execute and deliver this Agreement, and the Lenders have agreed to do so.

NOW, THEREFORE, in consideration of the foregoing premises, the mutual covenants and agreements of the parties hereto, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Termination of Collateral Assignment</u>. The Company and the Lenders hereby agree that the Patent Security Agreement and the Security Agreement are terminated and deemed of no further force or effect and that the Company shall have no further obligation thereunder.
- 2. Release of Security Interest. The Lenders hereby confirm the termination, cancellation, discharge and release any and all liens and security interests in and to the Patents, all registrations and applications for registration of the Patents (as well as any reissues,

extensions, divisions or continuations of the Patents), together with all of the Company's right to sue and recover for infringement of the Patents.

- 3. <u>Recording with USPTO</u>. Each of the Lenders hereby authorizes the Company to file and record this Agreement with the USPTO.
- 4. <u>Binding Effect</u>. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
- 5. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts each of which when so executed and delivered shall be deemed an original, but all of which together shall constitute one and the same instrument.




