GLAXOSMITHKLINE RESEARCH AND DEVELOPMENT LIMITED in turn hereby assigns and transfers to **GLAXO GROUP LIMITED** and **GLAXO GROUP LIMITED** hereby assigns and transfers to **GLAXO WELLCOME MANUFACTURING PTE LTD** its whole right, title and interest in all countries, including the United States of America, its territories and possessions in and to the invention and in and to the application including the right to claim priority from the application in respect of any subsequent applications, and in and to any divisional application, continuation or continuation in part application thereof, and in and to any Supplementary Protection Certificate, extension or re-issue thereof, and I/we the inventor(s) and **GLAXOSMITHKLINE S.P.A.**, **GLAXOSMITHKLINE RESEARCH AND DEVELOPMENT LIMITED** and **GLAXO GROUP LIMITED** hereby authorize and request any patent arising therefrom, in all countries, including the United States of America, its territories and possessions, be issued to **GLAXO WELLCOME MANUFACTURING PTE LTD**;




