The Commissioner of Patents and Trademarks is requested to issue such Letters Patent in accordance herewith. I-CON covenants that it is the lawful owner of the Patent Rights and all other patent applications and patents and the inventions and improvements therein disclosed, that the same are unencumbered, and that it has the full right to make this assignment.
