THIS CONFIRMATORY ASSIGNMENT is made this 1st day of September 2010

BETWEEN

WAYFINDER SYSTEMS AB ("Wayfinder"), a company registered in Sweden having its registered office at Box 1154, 221 05 Lund, Sweden

and

VODAFONE GROUP SERVICES LIMITED ("VGSL"), a company registered in England and Wales and having its registered office at Vodafone House, The Connection, Newbury, Berkshire, RG14 2FN, UK

and

VODAFONE GROUP PLC ("VGPLC"), a company registered in England and Wales and having its registered office at Vodafone House, The Connection, Newbury, Berkshire, RG14 2FN, UK

and

VODAFONE IP LICENSING LIMITED ("VIPLL"), a company registered in England and Wales and having its registered office at Vodafone House, The Connection, Newbury, Berkshire, RG14 2FN, UK

W H E R E A S:

(A) Wayfinder filed or acquired the patents and patent applications ("the Patents") listed in the schedule hereto for inventions ("the Inventions", which term includes any and all inventions disclosed in the Patents).

(B) Wayfinder and VGSL entered into an agreement dated the 23rd day of October 2009 ("the First Agreement") for the transfer from Wayfinder to VGSL of all rights, title and interest in and to the Patents including the right to claim priority.

For consideration of the sum of £1 and other good and valuable consideration, receipt of which Wayfinder hereby acknowledges, Wayfinder hereby confirms the assignment to VGSL with full title guarantee all rights, title and interest in and to the Patents and the Inventions together with all renewals, extensions, continuations, or divisional applications deriving therefrom, together with all rights of action arising therefrom including the right to sue for past infringement, together with the right to apply for, prosecute and obtain patent protection throughout the world in respect of the inventions claimed in or which form part of the assigned Patents and Inventions including the right to claim priority therefrom.

2. Wayfinder hereby agrees that it will at all times hereafter itself do all such acts and execute all such documents as may reasonably be necessary or desirable to give effect to this assignment.

3. For consideration of the sum of £1 and other good and valuable consideration, receipt of which VGSL hereby acknowledges, VGSL hereby confirms the assignment to VGPLC with full title guarantee all rights, title and interest in and to the Patents and the Inventions together with all renewals, extensions, continuations, or divisional applications deriving therefrom, together with all rights of action arising therefrom including the right to sue for past infringement, together with the right to apply for,

prosecute and obtain patent protection throughout the world in respect of the inventions claimed in or which form part of the assigned Patents and Inventions including the right to claim priority therefrom.

4. VGSL hereby agrees that it will at all times hereafter itself do all such acts and execute all such documents as may reasonably be necessary or desirable to give effect to this assignment.



5. For consideration of the sum of £1 and other good and valuable consideration, receipt of which VGPLC hereby acknowledges, VGPLC hereby confirms the assignment to VIPLL with full title guarantee all rights, title and interest in and to the Patents and the Inventions together with all renewals, extensions, continuations, or divisional applications deriving therefrom, together with all rights of action arising therefrom including the right to sue for past infringement, together with the right to apply for, prosecute and obtain patent protection throughout the world in respect of the inventions claimed in or which form part of the assigned Patents and Inventions including the right to claim priority therefrom.

6. VGPLC hereby agrees that it will at all times hereafter itself do all such acts and execute all such documents as may reasonably be necessary or desirable to give effect to this assignment.


