ASSIGNMENT

WHEREAS, Geoff G. Z. Zhang of Vernon Hills, IL 60061; Paul J. Brackemeyer of Mount Prospect, IL 60056; Nathaniel D. Catron of Vernon Hills, IL 60061 and Thomas B. The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment






