Fox, residing at 3365 New Salem Road, Climax, North Carolina 27233, Brian Bellamy Johnson, residing at 6301 Azalea Garden Drive, Atlanta, Georgia 30338, and Martin Richard Van Buren, residing at 7121 Madison Drive, Atlanta, Georgia 30346, have invented certain new and useful improvements for a **WINDOW COVERING SIZING METHOD AND APPARATUS**, for which we made application for Letters Patent of the United States, U.S. Patent Application No. 12/838,958 filed July 19, 2010 which is a continuation-in-part of U.S. Patent Application No. 12/164,839 filed June 30, 2008 which claims priority to U.S. Provisional Patent Application No. 61/010,291 filed January 7, 2008 and U.S. Provisional Patent Application No. 60/962,646 filed July 31, 2007.

And we do hereby request and authorize the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all said Letters Patent, when granted, in accordance with the terms of this assignment.

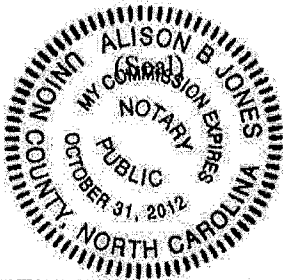

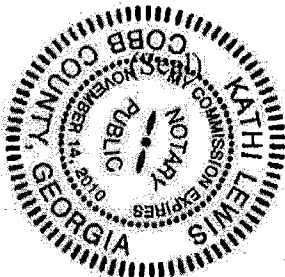

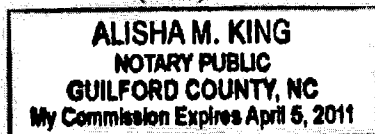
