DEED OF ASSIGNMENT

Parties:

(1) Cerberus Central Limited ("the Assignor"), a company registered in England under Company No. 03110832 and having the registered office: Buckingham House, West Street, Newbury, Berkshire, RG14 1BE, United Kingdom; and

(2) Stockford Limited ("the Assignee"), a company registered in England under Company No. 01606091, and having the registered office: 12 Sheet Street, Windsor, Berkshire, SL4 1BG, United Kingdom.

Recitals:

(A) The Assignor is the proprietor of United States Patent No. 7,457,515 B1 entitled Digital Data Distribution System ("the Patent") in respect of the invention claimed by the Patent ("the Invention"), the Patent being derived from International Patent Application No. PCT/GB00/04406 filed on 20 November 2000, which lists the Assignor's previous address of 2 Princes Street, London, W1R 7RA, United Kingdom.

(B) The Assignor has agreed to assign the Patent and the Invention to the Assignee as set out below.

Operative provisions:

1. In pursuance of the said agreement and in consideration of the sum of £1.00 (one British pound) now paid by the Assignee to the Assignor, the receipt and sufficiency of which is acknowledged by the Assignor, the Assignor HEREBY sell, assign and transfer to the Assignee, its successors and assigns:

1.1 all of the Assignor's right and title to and interest in the Invention and the full and exclusive benefit of it in the United States of America;

1.2 the Assignor's entire right, title and interest in and to the Patent and the inventions therein disclosed, and any improvements thereon, and any patent or patents that may be issued or reissued thereon, and hereby authorize and request the Commissioner of Patents and Trademarks to issue any letters patent thereon, and reissues thereof, to said Assignee, its successors and assigns, and hereby agrees that, upon request, Assignor will sign all papers, and make all rightful oaths, and do all acts which said Assignee, its successors or assigns, may consider necessary in connection with any patents issued or reissued thereon;

1.3 any other intellectual property rights that may be granted in respect of the Invention; and

1.4 the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of all infringements of the Patent whether such infringements take place before or after the date of this Assignment.


TO HOLD the same unto the Assignee absolutely.




