ASSIGNMENT

WHEREAS, WE, MARK K. CORNWALL, a citizen of the United States residing at 20 West 16th Avenue, Spokane, Washington 99203; BARRY CAHILL-O'BRIEN, a citizen of Ireland residing at 447 West 24th Avenue, Spokane, Washington 99203; and JOSEPH PAOLINO, a citizen of the United States residing at 13005 E. 37th Lane, Spokane Valley, Washington 99206 (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled GAS SHUT-OFF VALVE WITH FEEDBACK as described and set forth in a U.S. provisional patent application for Letters Patent of the United States of America, bearing U.S. Serial No. 61/247,066, which was filed in the U.S. Patent and Trademark Office on September 30, 2009 and as described in a patent application of the same title bearing U.S. Serial No. 12/892,985 which was filed in the U.S. Patent and Trademark Office on September 29, 2010;

AND WHEREAS, ITRON, INC. NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, WE, the said ASSIGNORS, by these presents do sell, assign and transfer unto the said ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive right, title and interest to the

said invention in the United States and all foreign countries, as described in the aforesaid application, together with the right of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention Relating to Patents, Designs and Industrial Models, and any other international agreements to which the United States of America adheres, and WE hereby authorize and request the Commissioner of Patents to record transfer of said Letters of Patent to the said ASSIGNEE, for its interest as ASSIGNEE, its successors, assigns and legal representatives.

And WE hereby agree to transfer a like interest, upon the request of the ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

Agreeing furthermore, upon request of said ASSIGNEE, and without further remuneration, to execute any and all papers desired by said ASSIGNEE for the filing and granting of foreign applications and the perfecting of title thereto in said ASSIGNEE.



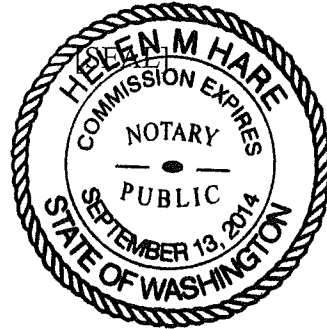
