## RELEASE OF SECURITY INTEREST IN PATENTS

**THIS RELEASE** dated as of November 17, 2010 (this "Release") is made by General Electric Capital Corporation, as agent for certain lenders ("Agent") under the Patent Security Agreements and Supplemental Patent Security Agreements dated as of May 11, 1998, and December 23, 1998, as amended, restated, supplemented or otherwise modified prior to the date hereof, and recorded in the records of the United States Patent and Trademark Office at Patent Reel 009396 Frame 0718, Reel 009423 Frame 0025, Reel 009935 Frame 0092, and Reel 009935 Frame 0758, between ICON Health & Fitness, Inc.
