ASSIGNMENT

countries or reissues thereof that may be granted therefor or thereon, for the full term for which said Letters Patent may be granted, together with the right to claim the priority of the above mentioned application (and any prior provisional application) in all foreign countries in accordance with international treaties and conventions, the same to be held and enjoyed by said ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by me if this assignment and sale had not been made.

I acknowledge that at the time the INVENTION was made, the INVENTION was subject to an obligation of assignment to said ASSIGNEE. I further acknowledge that said ASSIGNEE has the sole right to determine patent prosecution strategies with respect to said INVENTION and all corresponding applications, and hereby request that Letters Patent be issued in accordance with this assignment.

I covenant and agree that, at the time of the execution and delivery of these presents, I possess full title to said INVENTION and said application, and that I have the unencumbered right and authority to make this assignment.

I further covenant and agree to bind my heirs, legal representatives, and assigns, promptly to communicate to said ASSIGNEE or its representatives any facts known to me relating to said INVENTION, to testify in any interference or legal proceedings involving said INVENTION, to execute any additional papers that may be requested to confirm the right of the ASSIGNEE, its representatives, successors or assigns to secure patent or similar protection for said INVENTION in all countries and to vest in the ASSIGNEE

complete title to said INVENTION and Letters Patent,
without further compensation, but at the expense of the
ASSIGNEE, its successors, assigns and other legal
representatives.
