ASSIGNOR HEREBY AGREES to: (a) communicate to ASSIGNEE, its successors and assigns, or their representative or agents, all facts and information known or available to ASSIGNOR respecting the invention or inventions, improvements, and modifications including any and all evidence for any interference, reexamination, reissue, opposition, revocation, extension, or infringement purposes or other legal, judicial, or administrative proceedings, whenever requested by ASSIGNEE; (b) testify in person or by affidavit as required by ASSIGNEE, its successors and assigns, in any such proceeding in the United States or any other country; (c) execute and deliver, upon request by ASSIGNEE, all lawful papers including, but not limited to, any original, divisional, continuation, and any reissue applications, renewals, assignments, powers of attorney, oaths, affidavits, declarations and/or depositions; and (d) provide all reasonable assistance to ASSIGNEE, its successors and assigns, in obtaining and enforcing proper title in and protection for the invention or inventions, improvements, and modifications under the intellectual property laws of the United States and all other countries.

ASSIGNOR HEREBY REPRESENTS AND WARRANTS that ASSIGNOR has the full and unencumbered right to sell, assign, and transfer the interests sold, assigned, and transferred herein, and that ASSIGNOR has not executed and will not execute any document or instrument in conflict herewith.

ASSIGNOR HEREBY GRANTS to the law firm of **Butzel Long**, counsel for ASSIGNEE, the power and authority to insert into this Assignment any further identification necessary or desirable to comply with the rules of the U.S. Patent Office for recordation of this Assignment.

ASSIGNOR UNDERSTANDS AND AGREES that the attorneys and agents of the **Butzel Long** law firm represent the interests of both the ASSIGNEE and ASSIGNOR.
