ASSIGNMENT

WHEREAS I,

Johannes Robertus Maria FRANSSEN, (the "Inventor"), residing at Ter Hoogestraat 9, 4834 EC Breda, The Netherlands, am the sole designer of a design called ***handle for rail used in coverings for architectural openings*** for which design a European Community Registered Design application with serial number **001205249-0001** was filed in the OHIM Office on **26 March 2010**,

FURTHER I hereby authorize and request any official of any state, responsible for issuing patents or other evidence or forms of any industrial property protection, to issue the same for the design to the Company, its successors, legal representatives and assigns, in accordance with this assignment.

ALSO I hereby agree that I have the full right to convey my entire right, title and interest in and to the design world-wide and all applications for industrial property protection for the design world-wide and that I have not executed, and will not execute, any agreement in conflict with this assignment.

MOREOVER I hereby agree that I will communicate to the Company, its successors, legal representatives and assigns any facts known to me respecting the design and testify in any legal proceeding, sign any lawful papers, execute any original, divisional, continuation and reissue applications, make any rightful oaths, and generally do everything possible to aid the Company, its successors, legal representatives and assigns to obtain and enforce proper protection for the design world-wide.

FURTHER I hereby agree that this assignment is to be considered effective as of the filing date of the International Design application.
