The undersigned, Chris Savarese and Peter Cohn hereby certify that:

1. They are the Chief Executive Officer and Secretary, respectively, of Radar Golf, Inc., a California corporation.
2. Article I of the Amended and Restated Articles of Incorporation of this corporation shall be amended to read as follows:  
  
"The name of this corporation is Radar Corporation (the "Corporation")."
3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment was approved by the holders of the requisite number of shares of this corporation in accordance with Sections 902 and 903 of the California General Corporation Law. The total number of outstanding shares entitled to vote with respect to the foregoing amendment was 7,921,792 shares of Common Stock, 1,811,931 shares of Series A Preferred Stock and 8,536,813 shares of Series B Preferred Stock. The number of shares voting in favor of the foregoing amendment equaled or exceeded the vote required. The percentage vote required was (a) a majority of the outstanding shares of Common Stock, voting separately as a class, (b) a majority of the outstanding shares of Preferred Stock, voting separately as a class, and (c) a majority of the outstanding shares of Common Stock and Preferred Stock, voting together as a single class.
