AGREEMENT FOR RETENTION OF LICENSE FOR ASSIGNED PATENT RIGHTS

This Agreement is made the 1st day of November, 2010, between Paul Scherrer Institut, a company organized under the law of Switzerland (hereinafter called "Assignor") and Eulitha AG, a company organized under the law of Switzerland (hereinafter called "Assignee").

WHEREAS, Assignor, as the sole and exclusive owner of the patent rights identified in Schedule I attached hereto (hereinafter called "Patent Rights"), has previously assigned, as further described herein, its full right, title and interest in and to said Patent Rights to Assignee;

WHEREAS, Assignor and Assignee have agreed that Assignor shall have and retain certain license rights in respect of such previous assignments as recited herein.


NOW, THEREFORE, in consideration of the mutual promises and agreements herein contained and other good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor and Assignee agree and acknowledge that the Patent Rights have been assigned from Assignor to Assignee in Assignments duly recorded in the United States Patent and Trademark Office, Reel Frame Nos. 024747/0337 and 017142/0923.
2. It is further understood and agreed that the Assignments of Patent Rights are only for the specifically listed Patent Rights in Schedule I.
3. It is further understood and agreed that, as of the dates of the Assignments specified in Paragraph 1 above, Assignor shall retain for itself and Assignee hereby grants to Assignor, an irrevocable, royalty-free, worldwide, non-exclusive license under said Patent Rights to use, make, have made, and sell, or have sold on its behalf, any and all inventions disclosed in and/or covered by the Patent Rights.
4. The parties hereto agree that Assignor shall and shall have the right to record, or have recorded, this Agreement in the United States Patent and Trademark Office and any other offices or government agencies throughout the world that it deems necessary, and will inform Assignee of the recordation details.
