AND WE, the said Dorte Falk, Stefan Lux, Dietmar Peters, Carsten Schnier, Uwe Heidemann and Rolf Feldmann, do hereby authorize and request the Commissioner of Patents and Trademarks to issue the said Letters Patent of the United States to said Volkswagen AG and Traveltainer Beiteiligungs GmbH, as the assignees of

the entire right, title and interest in and to the same, for the sole use and benefit of said Volkswagen AG and Traveltainer Beiteiligungs GmbH, its successors and assigns;
