**ASSIGNMENT OF INVENTION**

WHEREAS, I, **Marco Lucchi**, residing at Concordiastrasse 33, Munchestein (BL), CH-4142, Switzerland, have invented a certain new and useful improvement in a "**Cleaning-In-Place System For Flat Belts**" for which an application for Letters Patent in the United States has been filed on **October 29, 2010** and assigned serial no. **12/915,258**.

And I hereby authorize and request the Director of U.S. Patent and Trademark Office to issue said United States Letters Patent to said **Habasit AG** as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for the aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
