
(hereinafter referred to as the "Invention") for which we have executed an Application for United States Patent having Serial No. 29/380,247 and a filing date of December 2, 2010


And we hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to Assignee;
