ATTENTION

1. The Enterprise Legal Entity Business License (the "License") is a certificate to establish an enterprise's legal entity status and its lawful authority to do business.
2. The License is issued in original and duplicate copies. Each copy shall have the same legal effect as the original.
3. The original License shall be conspicuously displayed at an enterprise's place of business.
4. Any fabrication, alteration, renting, leasing or transferring of the License is prohibited by law.
5. On occurrence of any changes to the items recited herein, an enterprise shall immediately notify the registration office and apply for an updated License.
6. An enterprise is required to receive an annual inspection between March 1 and June 30 each year.
7. After the License is cancelled, an enterprise cannot conduct any business except for those related to its liquidation.
8. To cancel the License, an enterprise must surrender to the registration office the original and duplicate copies of such License.
9. After loss of, or damage to, the License, an enterprise shall announce the annulment of such License on a newspaper designated by the registration office and apply for a new license in replacement.
