

ASSIGNMENT

WHEREAS, I, MICHAEL BARTON, have invented a new original and ornamental design for a WINDOW LOCK for which I have made application for Letters Patent of the United States of America; and

called upon, and will sign all instruments and documents and render such assistance which in the judgment of said corporation is necessary to vest in it and protect the legal title sought to be assigned.
