RELEASE OF LIEN ON TRADEMARKS AND PATENTS

This RELEASE OF LIEN ON TRADEMARKS AND PATENTS (this "Release"), dated as of December 9, 2010 is made by GB MERCHANT PARTNERS, LLC, with an address of 101 Huntington Avenue, 10th Floor, Boston, Massachusetts 02199, in its capacity as administrative agent (the "Administrative Agent") pursuant to pursuant to the Loan Agreement referred to below in favor of THE BOMBAY COMPANY, INC., a Delaware corporation, BBA HOLDINGS, LLC, a Delaware limited liability company, and BOMBAY INTERNATIONAL, INC., a Delaware corporation (the "Grantors"). Capitalized terms used herein and not otherwise defined shall have the meanings set forth in or incorporated by reference into the Loan Agreement.

WHEREAS, pursuant to the Term Loan Agreement, dated as of May 25, 2007, by and among the Borrowers, the Lenders, and the Administrative Agent (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), the Lenders agreed to make the Term Loan to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Loan Agreement, the Grantors entered into an Intellectual Property Security Agreement dated as of June 4, 2007 and recorded in the United States Patent and Trademark Office as of June 13, 2007 at Reel 3560, Frame 0114 with respect to trademarks and as of June 13, 2007 at Reel 019419, Frame 0161 with respect to patents (the "IP Security Agreement") pursuant to which the Grantors granted to the Administrative Agent a security interest in and lien on all right, title and interest of the Grantors in certain trademarks and patents, including the trademarks, trademark applications and patents set forth on Schedule I attached hereto (the "Released IP") to secure the performance of certain obligations (the "Obligations"); and

WHEREAS, the Obligations have now been satisfied and the Grantors have requested that the Administrative Agent release any and all right, title and interest it and the other secured parties may have in the Released IP pursuant to the IP Security Agreement, and the Administrative Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release, relinquish and discharge its security interest in, to and under the Released IP and all right, title and interest of the Grantors in the Released IP is hereby reassigned to the Grantors.

The Administrative Agent shall provide the Grantors, their successors and assigns, or their legal representatives, such information and assistance as the Grantors may reasonably request (including, without limitation, execution and delivery of any documents as may be reasonably required) in connection with filing the appropriate documentation with the appropriate authority to perfect the release of the security interest on the Released IP. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date set forth above.
