ASSIGNMENT

WHEREAS I, KIM, Jun-Ho of 102-102 Beomecowobang Elysion, 92-2 Beomeo 4-dong, Suseong-gu, Daegu 706-014 Republic of Korea (hereinafter referred to as "ASSIGNOR") have invented certain new and useful improvements in:

DISPENSARY MANAGEMENT SYSTEM AND METHOD

The undersigned declare that all statements made herein of his own knowledge are true and that all statements made on information and belief are believed to be true; and further that

these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issuing thereon.
