RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (the "Release") is made as of December 9, 2010, by U.S. Bank, National Association ("U.S. Bank"), as successor to Wells Fargo Bank, National Association ("Wells Fargo"), in its capacity as Collateral Trustee for the Secured Parties as defined in the Security Agreement referenced below (in such capacity, the "Collateral Trustee"), in favor of Abitibi-Consolidated Inc. (the "Grantor").

WHEREAS, in connection with that certain Indenture, dated as of April 1, 2008, by and among Abitibi-Consolidated Company of Canada, as Issuer, the Guarantors party thereto, and U.S. Bank, as Trustee and Collateral Trustee (as amended, supplemented, or otherwise modified from time to time, the "Indenture"), Grantor executed a Patent Security Agreement dated as of April 1, 2008 in favor of the Collateral Trustee (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") for the purpose of securing certain obligations of Grantor and certain of its affiliates to the Collateral Trustee under the Indenture;

WHEREAS, pursuant to the Security Agreement, Grantor has granted the Collateral Trustee a security interest in, among other things, the patents and patent applications listed on Exhibit A attached hereto (the "Patents"), and pledged and mortgaged (but did not transfer title to) the Patents to the Collateral Trustee; and

WHEREAS, as of the date hereof, the Collateral Trustee's liens on and security interests in the Patents have terminated and are of no further force and effect.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Trustee hereby agrees as follows:

The Collateral Trustee hereby terminates and releases its liens on and security interests in the Patents, and the Collateral Trustee hereby assigns and transfers to the Grantor, without any representation, warranty or recourse whatsoever, the Collateral Trustee's entire right, title and interest in and to the Patents, effective as of the date set forth above.

The Collateral Trustee authorizes and requests that the Commissioner of Patents and any other applicable government officer record this Release.
