ASSIGNMENT

WHEREAS, we, Chris Piniarski, of city of San Diego, State of California, Robert Nunez, of city of San Diego, State of California, Sean Toulon, of city of Vista, State of California, and Thomas Olsavsky, of city of Oceanside, State of California, have invented a certain design for GOLF CLUB HEAD for which we have made application for Letters Patent of the United States, said application having been filed on October 13, 2010, and assigned Application No. 29/376,895; and

and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and do everything possible to aid Taylor Made Golf Company, Inc., its successors and assigns to obtain and enforce proper patent protection for said invention in this or any foreign country.

We confirm that at the time the invention was made, we were under an obligation to assign the invention to Taylor Made Golf Company, Inc.

We hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of United States Patent and Trademark Office, for submitting and recording this document.

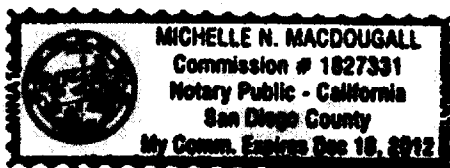

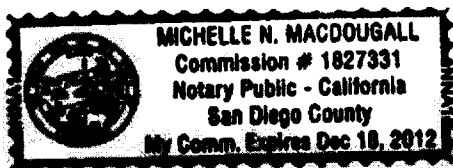
