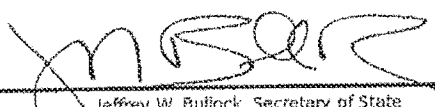

CERTIFICATE OF OWNERSHIP AND MERGER

It is hereby certified that:

1. SAP America, Inc. (hereinafter sometimes referred to as the "Corporation") is a business corporation of the State of Delaware.
2. The Corporation, effective July 1, 2009 at 12:01 a.m. Eastern Daylight Savings Time is the owner of all of the outstanding shares of the capital stock of Business Objects Americas, which is also a business corporation of the State of Delaware.
3. On June 30, 2009, the Board of Directors of the Corporation adopted the following resolutions to merge Business Objects Americas with and into the Corporation:

RESOLVED, that following acquisition of all of the outstanding shares of the capital stock of Business Objects Americas, the Corporation will cause Business Objects Americas to be merged with and into the Corporation, and that all of the estate, property, rights, privileges, powers and franchises of Business Objects Americas be vested in and held and enjoyed by the Corporation as fully and entirely and without change or diminution as the same were before held and enjoyed by Business Objects Americas in its name.

FURTHER RESOLVED, that the Corporation shall assume all of the obligations of Business Objects Americas.

FURTHER RESOLVED, that the Corporation shall cause to be executed and filed and/or recorded the documents prescribed by the laws of the State of Delaware and by the laws of any other appropriate jurisdiction and will cause to be performed all necessary acts within the State of Delaware and within any other appropriate jurisdiction.

FURTHER RESOLVED, that the effective time of the Certificate of Ownership and Merger setting forth a copy of these resolutions, and the time when the merger therein provided for, shall be July 1, 2009 at 12:30 a.m. Eastern Daylight Savings Time.
