RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **December 6, 2010** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Security Agreement, dated as of **July 11, 2006** and recorded on **September 26, 2006 in Reel 018302 Frame 0570**, in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Diffraction, Ltd.**, (the "Debtor") and the Secured Party;

Intellectual Property Collateral including those set forth, and discharges, quit claims and relinquishes unto **Diffraction, Ltd.**, (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and the security interest granted to Secured Party in the Intellectual Property Collateral.


