ASSIGNMENT

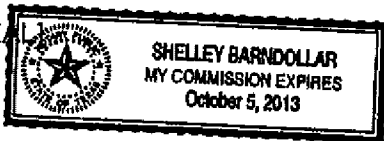



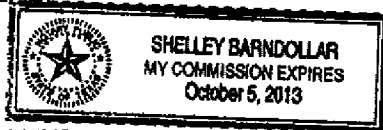
