AND I HEREBY FURTHER covenant and agree that this Assignment is effective as of 01 November 2010.

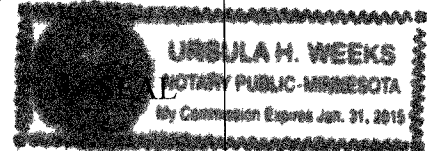

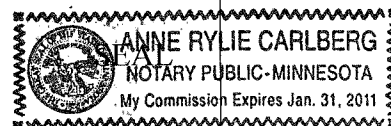
