ASSIGNMENT OF UNITED STATES PATENTS

Background of this Assignment

2. Consideration: In consideration for the assignment of the Patents, the Assignee is paying ten United State dollars (\$10.00), and is providing other good and valuable consideration as set forth in the Agreement on Sale of Assets, to the Assignors.
3. Agreement on Sale of Assets: The rights and obligations of the Assignor and the Assignee relating to this Assignment are subject to, and limited by, the Agreement on Sale of Assets.
