Assignment

Whereas, William Hong, an individual, residing at 15600 Bandon Drive, Austin, Texas 78717 ("Applicants"), has invented certain new and useful improvements in a SYSTEM AND METHOD FOR CONNECTING A MASTER DEVICE WITH MULTIPLE GROUPINGS OF SLAVE DEVICES VIA A LINBUS NETWORK (the "Invention"), for which United States Patent Application was filed on December 31, 2007 (Serial No. 11/967,713) (the "Application"); and



Applicant further agrees to communicate to Assignee, its successors, assigns and/or legal representatives, any known facts respecting any improvements, and, at the expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in Assignee and to aid Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for the Invention in all countries.

Applicant further authorizes and directs Assignee's attorneys to insert the serial number and filing date of said application now identified by the attorney docket number and title set forth above as soon as the same shall have been made known to them by the United States Patent and Trademark Office.

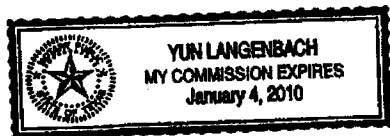


