- INFORMATION FOR JUDGMENT DEBTOR -

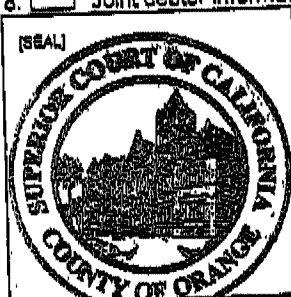
