WHEREAS, I, Michael V. Pishko, residing at 604 Benchmark Drive, College Station, Texas 77845, made certain new and useful inventions and improvements for which Letters Patent of the United States issued on January 14, 1997 and October 12, 1999 as U.S. Patent No. 5,593,852 and U.S. Patent No. 5,965,380 respectively, both of which are entitled SUBCUTANEOUS GLUCOSE ELECTRODE. AND, for the consideration aforesaid, I do hereby agree that I and my executors and legal representatives will make, execute and deliver any and all other instruments in writing including any and all further application papers, affidavits, assignments and other documents, and will communicate to said Assignee, its successors and representatives all facts known to me relating to said improvements and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable more effectually to secure to and vest in said Assignee, its successors or assigns the entire right, title and interest in and to the improvements, inventions, applications, Letters Patent, rights, titles, benefits, privileges and advantages hereby sold, assigned and conveyed, or intended so to be.

AND, furthermore I covenant and agree with said Assignee, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by me and that full right to convey the same as herein expressed is possessed by me.
