DEED OF ASSIGNMENT

THIS AGREEMENT IS MADE AS A DEED ON 3 DECEMBER 2001

PARTIES

THE UNIVERSITY OF NEW SOUTH WALES of Anzac Parade, Kensington, New South Wales (UNSW)

DSM FOOD SPECIALTIES AUSTRALIA PTY LIMITED ACN 003 994 198 of 9 Moorebank Avenue, Moorebank, New South Wales (DSM)

FOOD TECHNOLOGY INNOVATIONS PTY LIMITED ACN 081 936 861 of G13 Biological Sciences Building, The University of New South Wales, Anzac Parade, Kensington, New South Wales (FTI)

PENFORD HOLDINGS PTY LIMITED ACN 094 279 339 of 170 Epping Road, Lane Cove, New South Wales (Penford)

BACKGROUND

- A. The parties are the owners of the Assets.
- B. UNSW, DSM and FTI have agreed to assign to Penford or its nominee their right and title to and interest in the Assets on the terms set out in this agreement.

AGREEMENTS

1. DEFINITIONS

Assets means the Patents and the Intellectual Property;

Centre means the Cooperative Research Centre for Food Industry Innovation;

GST has the same meaning as in section 195-1 of the *A New Tax System (Goods and Services Tax) Act 1999*;

Intellectual Property means any copyright, registered and unregistered trade marks, registered and unregistered designs, confidential information, know-how and trade secrets arising out of the development of, or subsisting in the materials used to create, the Patents; and

Patents means the patent applications and registrations specified in the schedule, including reissues, divisionals and continuing applications thereof.

2. ASSIGNMENTS

2.1 Patents

- 2.1.1 UNSW and DSM assign to Penford or its nominee their right and title to and interest in the Patents, for the remainder of those rights, including all renewals and extensions.
- 2.1.2 FTI assigns to Penford or its nominee its right and title to and interest in the Patents, for the remainder of those rights, including all renewals and extensions.

2.2 Intellectual Property

UNSW, DSM and FTI assign to Penford or its nominee their right and title to and interest in the Intellectual Property.

3. ACKNOWLEDGMENTS

Penford:

- (a) accepts the title that UNSW, DSM and FTI have to the rights, title and interests assigned by this agreement;
- (b) acknowledges that UNSW, DSM and FTI make no representation or warranty that the Assets do not or will not infringe any other person's rights; and
- (c) acknowledges that it is responsible for all costs associated with maintaining the Assets.

4. AMENDMENT

This agreement may only be varied by the written agreement of the parties.

5. FURTHER ASSURANCE

Each party must sign all documents and do all things that another party from time to time reasonably requests to effect, perfect or complete this agreement.

6. GST

In relation to any GST payable for a taxable supply (as defined under GST law) by a party under this agreement, the recipient of the supply must pay the GST subject to the supplier providing a tax invoice (as defined under GST law).

7. GOVERNING LAW AND JURISDICTION

This agreement is governed by and must be construed in accordance with the laws of New South Wales. Each party:

- (a) irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of New South Wales and all courts which have jurisdiction to hear appeals from those courts; and

(b) waives any right to object to proceedings being brought in those courts for any reason.

8. ENTIRE AGREEMENT

This agreement embodies the entire understanding and agreement between the parties as to its subject matter.
