Under Section 251 of the General Corporation Law of the State of Delaware

Pursuant to Section 251 of the General Corporation Law of the State of Delaware, KASENNA, INC., a Delaware Corporation ("Kassenna"), hereby certifies the following information relating to the merger (the "Merger") of EGIKI Acquisition, Corp. ("EGIKI"), a Delaware Corporation with and into Kasenna, Inc., a Delaware Corporation (the "Surviving Corporation"):

1. The names and states of incorporation of EGIKI and Kasenna, which are the constituent corporations in the Merger (the "Constituent Corporations"), are:

The Merger Agreement dated as of June 30, 2008, as amended July 10, 2008 (the "Merger Agreement") by and among EGIKI, Kasenna and Espial Group Inc., a corporation incorporated under the *Canada Business Corporations Act* and parent corporation of EGIKI, and a representative of the stockholders of Kasenna, setting forth the terms and conditions of the Merger, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations, in accordance with the provisions of Section 251 of the General Corporation Law of the State of Delaware. The Merger shall be effective as of the time of filing this certificate.

3. The corporation surviving the Merger is Kasenna and its name shall be changed to "Espial, Inc."

4. The certificate of incorporation of Kasenna, Inc. shall be the certificate of incorporation of the Surviving Corporation.

5. An executed Merger Agreement is on file at the principal place of business of the Surviving Corporation, which is located at 1196 Borregas Avenue, Suite 100, Sunnyvale, CA 94089-1302.


6. A copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder of either of the Constituent Corporations.
