WHEREAS, I, a citizen of the United States, residing at Asheville, North Carolina; (hereinafter referred to as "ASSIGNOR"), have invented certain new and useful improvements in *Computerized System for Blood Chemistry Monitoring* for which an application for a United States patent was filed on February 26, 2010 under Serial No. **12/713,934** and a European patent was filed on March 29, 2010 under Serial No. **08798440.7**; which applications claim priority from international application Serial No. **PCT/US08/73959** filed August 22, 2008 which claims priority from United States provisional application Serial Nos. **60/969,582** filed August 31, 2007 and **60/973,891** filed September 20, 2007; all applications listed above being hereinafter referred to as the "APPLICATION" and;

I hereby request that said Letters Patent be issued in accordance with this assignment.

I further covenant and agree that, at the time of the execution and delivery of these presents, I have the unencumbered right and authority to make this assignment.

I further covenant and agree to bind my heirs, legal representatives, and assigns, promptly to communicate to the ASSIGNEE or its representatives any facts known to me relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers that may be requested to confirm the right of the ASSIGNEE, its representatives, successors or assigns to secure patent or similar protection for said invention in all countries and to vest in the ASSIGNEE complete title to said invention and Letters Patent, without further compensation, but at the expense of the ASSIGNEE, its successors, assigns and other legal representatives.





