PATENT ASSIGNMENT

This PATENT ASSIGNMENT ("Assignment") dated as of December 21, 2010 (the "Effective Date") is made by and between Ahlstrom Corporation, a Finish corporation with an office at P.O. Box 329, Salmisaarenaukio 1, FI-00101 Helsinki, Finland ("Assignor") and Polyester Fibers, LLC, a Delaware limited liability company with an office at 703 Waterford Way, Suite 520, Miami, Florida 33126 ("Assignee").

WHEREAS, Assignor has agreed to assign its worldwide right, title and interest in and to each issued patent and each pending patent application listed in the attached Schedule I hereto (collectively, the "Patents"); and

WHEREAS, Assignee desires to receive an assignment of the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby sells, assigns and transfers to Assignee, and Assignee hereby accepts the sale, assignment and transfer from Assignor of all of Assignor's right, title and interest throughout the world in and to: (i) the Patents, including divisionals, continuations, continuations-in-part, re-issues and reexaminations thereof, including any other counterparts thereto worldwide, patents of addition, utility models, inventors' certificates, industrial property protection, patent rights and right to claim priority thereto in any country, and all extensions and renewals thereof existing now or in the future and any licenses or sublicenses pertaining to the Patents (with the Patents, collectively, the "Patent Property"), and (ii) all claims, demands, income, damages, royalties, and rights of action, both statutory and based upon common law, that Assignor has or might have by reason of any infringement of any of the Patents or Patent Property prior to, on, or after the date of this Assignment, together with the right to prosecute such claims, demands, and rights of action in Assignee's own name.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

Assignor hereby represents and warrants to Assignee that Assignor has good and marketable title to the Patent Property, free and clear of all liens, mortgages, pledges, claims, security interests, title defects, encumbrances, charges, conditions, rights of another, and other restrictions of every kind.

Assignor hereby covenants and agrees that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

Assignor hereby further covenants and agrees that it will communicate to the Assignee, its successors, legal representatives and assigns, any facts known to it respecting the

Patent Property, testify in any legal proceeding relating to the Patent Property, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything reasonably possible to aid the Assignee or its successors, legal representatives and assigns, to obtain and enforce proper protection for the Patent Property in all countries.

This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware without regard to the conflicts of law provisions thereof.




