THIS ASSIGNMENT is made as a deed on 25th July

2003

BETWEEN

(1) BTG INTERNATIONAL LIMITED whose company registration number in England and Wales is 2664412 and whose registered address is at 10 Fleet Place, Limeburner Lane, London, EC4M 7SB, England ("BTG"), and

(2) ROTHAMSTED RESEARCH LIMITED whose company registration number in England is 2393175 and whose registered address is at Harpenden, Hertfordshire, AL5 2JQ, England (the "INSTITUTION").

WHEREAS:-

A. BTG is the proprietor and/or beneficial owner of the patents and applications, details of which are set out in the Schedule to this Agreement, (all such patents, applications, are herein together called the "IPR").

B. The INSTITUTION and BTG have agreed that the IPR shall be assigned to the INSTITUTION on the terms hereinafter set forth.

NOW IT IS HEREBY AGREED as follows:-

1. BTG hereby assigns to the INSTITUTION all its right, title, and interest in the IPR, free from encumbrances, except for encumbrances disclosed or otherwise known to the INSTITUTION, and together with all rights transferable with such encumbrances.

2. (1) BTG shall, at the request and cost of the INSTITUTION, execute and do all such documents, acts and things as may be necessary on the part of BTG to give effect to the terms of this Agreement.

(2) BTG hereby confirms that, as at the date of this Agreement, it is not aware of any unauthorised use of any of the IPR.

3. THE INSTITUTION hereby agrees with BTG that:-

(1) the INSTITUTION will, within 90 days after the date of receipt thereof, pay to BTG 50% of all payments (if any) received in respect of the licensing, manufacture, sale or other commercialisation of the IPR, until the aggregate of all such payments to BTG amounts to the sum of £11,420.22.

(2) the INSTITUTION will keep proper accounts of its receipts which are the subject of sub-clause (1) of this clause, and that it will on request produce the same for inspection by the duly authorised representative of BTG together with any invoices or vouchers relating thereto for the purpose of verification.

(3) the INSTITUTION will not, without the prior written consent of BTG, assign or otherwise part with possession of its rights in the IPR (except by way of licence thereunder) until the said sum of £11,420.22 has been paid to BTG.

4. IT is hereby agreed that the IPR and the sums paid pursuant to clause 3 above shall, with effect from the date of this Agreement, be deemed to be excluded from the terms of the DEVELOPMENT SUPPORT AND TECHNOLOGY TRANSFER AGREEMENT.



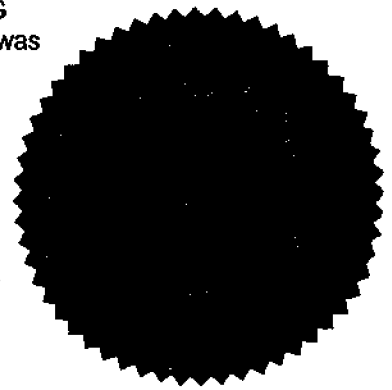

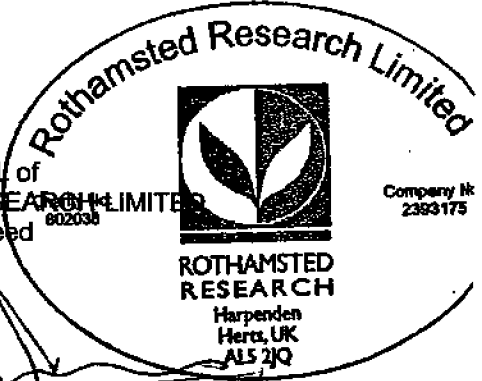
