ASSIGNMENTS

WHEREAS; Infineon Technologies AG ("Infineon"), a stock corporation (Aktiengesellschaft) existing under the laws of the Federal Republic of Germany, was party to an assignment agreement executed by Infineon on May 3, 2010 by which it intended to assign all right, title and interest in and to the U.S. patents and applications listed on the enclosure hereto to Lantiq Deutschland GmbH but which inadvertently named Infineon Technologies Wireless Solutions GmbH as the recipient of such right, title and interest in and to the U.S. patents and applications;

WHEREAS; Infineon Technologies Wireless Solutions GmbH ("Infineon Wireless"), a limited liability company (Gesellschaft mit beschränkter Haftung) existing under the laws of the Federal Republic of Germany, was not a party to but was inadvertently named in the aforementioned assignment agreement as the recipient of all right, title and interest in and to the aforementioned U.S. patents and applications;

WHEREAS; Lantiq Deutschland GmbH ("Lantiq"), a limited liability company (Gesellschaft mit beschränkter Haftung) existing under the laws of the Federal Republic of Germany, was the intended recipient of all right, title and interest in and to said U.S. patents and applications conveyed by the aforementioned assignment agreement which Lantiq was a party to and executed on May 5, 2010;

WHEREAS; Infineon, Infineon Wireless and Lantiq all agree that Infineon intended to assign all right, title and interest in and to aforementioned U.S. patents and applications conveyed by the aforementioned assignment agreement to Lantiq, and that the identification of Infineon Wireless as the recipient of such right, title and interest in and to the U.S. patents and applications was the result of a clerical error;

WHEREAS; Infineon, Infineon Wireless and Lantiq all believe that the aforementioned assignment agreement was fully effective to assign all right, title and interest in and to aforementioned U.S. patents and applications identified therein to Lantiq; and WHEREAS; Infineon, Infineon Wireless and Lantiq desire to ensure the assignment of all right, title and interest in and to aforementioned U.S. patents and applications identified therein to Lantiq;

Now, therefore, for one dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Infineon, hereby quitclaims, assigns, sells and sets over unto Lantiq, its assignees and legal representatives, all right, title and interest in and to said U.S. patents/applications, including any right to sue and recover damages for past infringement, to file continuation, divisional, counterpart, and/or other applications claiming the priority of said U.S. patents/applications, as well as all rights to the inventions described in said U.S. patents/applications; and

For one dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Infineon Wireless, hereby quitclaims, assigns, sells and sets over unto Lantiq, its assignees and legal representatives, all right, title and interest in and to said U.S. patents/applications, including any right to sue and recover damages for past infringements, to file continuation, divisional, counterpart, and/or other applications claiming the priority of said U.S. patents/applications, as well as all rights to the inventions described in said U.S. patents/applications.

The effective date of these assignments is February 9, 2010, retroactively.
